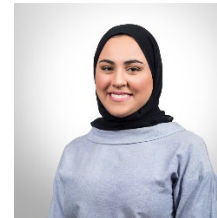

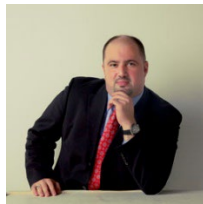

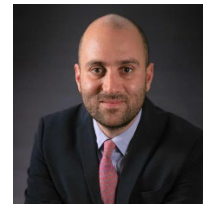

**SECURITIES & EQUITY – HOW TO REGISTER & ENFORCE  
SECURITIES EFFECTIVELY**

This session will explore how securities and equity interests are registered and enforced across various jurisdictions, with insights from Mauritius, the UAE, Morocco, Kuwait, and others. Speakers will address the Mauritian framework for securing interests in shares, movable and immovable property, and the role of registration with public registries. From a UAE perspective, the discussion will highlight whether security can be created directly in favor of a foreign financial institution or if a security agency structure is required. The session will also examine enforcement mechanisms in the event of default, including judicial remedies and receiverships, while considering cross-border issues and best practices to strengthen creditor protection without undermining commercial flexibility.
